

**NOTICE OF PUBLIC HEARING & ADOPTION OF A HEALTH
REGULATION ENTITLED
“DISTRICT HEALTH DEPARTMENT NO. 4 SANITARY CODE 2009”**

The Board of Health for District Health Department No. 4 will hold a Public Hearings in Alpena, Cheboygan, Montmorency and Presque Isle Counties.

The purpose of the hearings is to receive public comment regarding updates and revisions for amending the Sanitary Code. The Sanitary Code regulates private and public drinking water supplies, the proper treatment and disposal of wastewater as well as other parameters.

Public comment by data, views and arguments on the proposed regulation may be offered by any person at the hearing. Written comments may be submitted at any of the public hearings.

The proposed regulation of the District Health Department #4 will apply to Alpena, Cheboygan, Montmorency and Presque Isle Counties if adopted by the Board of Health and approved by the Boards of Commissioners of each County.

At the conclusion of the public hearings, the Board of Health shall consider adopting the “District Health Department No. 4 Sanitary Code 2009” on Tuesday June 16, 2009.

The Board of Health shall also consider the repeal of a prior regulation adopted on April 18, 1995, Effective July 1, 1995 and Amended August 16, 1997 Effective January 1, 1997 and Amended October 10, 2007, Effective January 1, 2008.

The "District Health Department No. 4 Sanitary Code 2009" shall be effective 60 days from and after the date on which the last of counties Alpena, Cheboygan, Montmorency or Presque Isle County, by their respective Boards of Commissioners approve this regulation.
